Position Title: IT Manager

Purpose of Position

To ensure that FFS IT Infrastructure, related IT support services and COMET System are robust, efficient and effective at all times.

Key Relationships

Responsible to: Head of Corporate Services, Technical Director and the Chief Executive Officer

Duties and Responsibilities

Network Maintenance

- Operate and maintain FFS network
- Operate and maintain COMET System and ensure that information on system is relevant and current
- Ensure that FFS personnel have reliable, secure, stable and sufficient access to network/server and desktop resources to carry out their duties
- Ensure adequate Data and Network Security measures are in place
- Safeguard hardware, software and data at all times
- Ensure that electronic systems are secure from virus and any unauthorised intrusions/access
- Oversee the operation and maintenance of all ICT systems. Develop and conduct maintenance schedule for all ICT systems
- Oversee the FFS website in collaboration with the FFS Media Officer

Software Maintenance:

- Ensure proper maintenance of computer systems, user applications and Active directory
- Manage Server, Printing, Mail and File Server; Web server

IT Procurement and register:

- Maintain and update the FFS Information Communication Technology (ICT) asset register
- Enquire and analyse specification, quotes, pricing from Providers before purchasing any ICT equipment

Ensure compliance with ICT policy:

- Prepare and implement ICT and ICT related Policies and Procedures
- Ensure FFS staff abides with ICT policies and procedures at all times

Other:

- Ensure ongoing improvement of FFS's electronic systems and equipment
- Supervise ICT and Media Team allocate appropriate work for them

Selection Criteria

Qualification:

- Bachelor's Degree in Computer Science or Related Field
- At least 3 years' experience in IT systems management
- At least 3 years' experience as a Senior Officer

Technical Skills:

- Network planning, designing and maintenance skills – ability to install/configure network devices and software and troubleshoot
- Technical knowledge of COMET System
- Technical knowledge of IT Systems & Microsoft Systems – ability to operate and maintain IT Systems & Microsoft Systems and Software
- Technical knowledge of operating systems and software
- Familiar with COMMET System and ability to operate system
- Technical knowledge of PC Hardware – ability to repair PC Hardware
- Can install and configure CCTV cameras
- Communication and Presentation – communicates clearly in English and Samoan, both verbal and written

Personal Attributes:

- Commitment and Personal Drive - Work effortlessly in any circumstances. Committed to work, team and organisation by cooperating in team activities. Works well with team to achieve a common goal.
- Honesty - Acts with integrity at all times. Demonstrates precision when performing duties.
- Demonstrates precision in work operations

Remuneration
